Gifts that produce life income are a good choice if you would like to supplement your income and receive a tax benefit while providing a gift to support an International Ministries initiative that is especially meaningful to you. By choosing a Charitable Gift Annuity, you are making an investment in the future of global mission.



### HOW?

You can transfer cash or securities to establish a Charitable Gift Annuity with International Ministries. When you do, we will make fixed payments to you for life. The gift portion of a Charitable Gift Annuity qualifies for a charitable tax deduction.

Funding your gift with appreciated securities can be an excellent means of minimizing capital gains taxes. If you fund your gift annuity with cash, a significant part of your fixed payment will be tax-free.

If you own assets that are providing little or no income, gifting those assets to International Ministries in order to set up annuity payments for life could be a good option.

### WHY?
